## **2012-2013 FEES, TUITION, & TUITION ASSISTANCE INFORMATION**

### **FEES**

#### **ALL FEES ARE IN ADDITION TO TUITION AND ARE NON-REFUNDABLE.**

We make commitments to the purchase of books and supplies prior to the start of classes. We must pay these charges whether your student attends or not, therefore no fees are refundable.

### **APPLICATION FEE**

An Application Fee (\$205.00 freshman and new students, \$180.00 for returning students) is due at the time application materials are submitted to the school.

### **STUDENT FEES due July 2, 2012**

An annual fee of **\$730.00** for freshmen & sophomores, **\$775.00** for juniors & **\$880.00** (includes graduation and economics fee) for seniors will be charged to cover books, including textbooks, all workbooks and paperbacks, activity fee, campus ministry, nurse, technology, transportation, parking, locker fee, mandatory testing fees, Booster fee, and instructional budgets for English, Science, Math, P.E., Social Studies and Theology (does not include voluntary testing fees, retreats, extracurricular participant fee, spirit packs or other types of clothing).

### **BUILDING MAINTENANCE FEE due July 2, 2012**

All new students are assessed a \$200.00 Building Maintenance Fee.

### **TUITION**

Tuition is payable annually, semi-annually or monthly, according to the applicable tuition payment category. ***Final payment is due no later than May 10, 2013.*** Student transcripts, will not be released unless the account is paid in full. We accept payment by cash or check, or electronic withdrawal via check, Visa or MasterCard. **Payment by Electronic Funds Transfer or credit card is mandatory for the monthly tuition option.** ***A 2.5% convenience fee is added to ALL credit card transactions.***

### **EXTRACURRICULAR PARTICIPANT FEE**

An \$85 fee will be charged to each participant of each extracurricular activity (all athletic teams, cheerleading, etc.)

### **SPIRIT PACKS**

Depending on the extracurricular activities your student participates in, there may be additional charges for clothing, bags, hats, etc. This is optional. **If you do not want to purchase spirit packs, please ask your student not to order them.**

### **BUS TRANSPORTATION AVAILABLE FROM NAMPA and EAGLE**

A \$300.00 fee applies each semester that the student utilizes the bus. Information is available in the Attendance Office 377-9928. There is a annual fee of \$25.00 for bus registration.

### **TRANSCRIPTS**

The first three transcripts are provided at no charge. On the fourth and all successive transcript requests there is a charge of \$2.00 per transcript. All FAX transcripts cost \$5.00 each.

### **WITHDRAWAL PROCESSING FEE**

There is a fee of \$25.00 if a student should withdraw before the end of the year.

## TEXTBOOKS

ALL TEXTBOOKS ARE DUE BACK TO THE TEACHER AT THE TIME OF THE FINAL EXAM. IF THE BOOK IS NOT RETURNED BY THE DAY OF THE FINAL EXAM YOU WILL BE CHARGED AND RESPONSIBLE FOR THE FULL REPLACEMENT COST OF THE TEXTBOOK. CREDIT WILL NOT BE ISSUED FOR BOOKS RETURNED AFTER THE LAST DAY OF SCHOOL.

A Rental Fee for hardbound textbooks is included in the Student Fee. However, the replacement cost of a textbook will be charged under the following conditions:

- **The book is lost or stolen**
- **The same student does not check back in the book originally checked out by a student.**
- **There is ANY writing on or in the textbook.**
- **The cover of the book is torn, written on, or bent.**
- **There is any water damage.**
- **If you would like to purchase any of the textbooks, we will provide you the information you will need to purchase them from an outside source.**

## LATE PAYMENT FEE and Electronic Funds Transfer & CHECK RETURN FEE

Late payments will be assessed a fee of 1.5%/month. A \$20.00 fee will be charged for returned EFT and check payments. **Postdated checks are not accepted.**

## REFUND POLICY

A student withdrawing from Bishop Kelly High School will receive a tuition refund based on a monthly rate. All fees are non-refundable.

## COLLECTION POLICY

If necessary, we will use a collection agency to collect on delinquent accounts.

## TIERED TUITION

Tiered tuition is available to families with more than one child attending Bishop Kelly HS. Students must reside in the same household. To be eligible for tiered tuition, fill out the table on the tuition contract. The following discounts apply:

## TUITION ASSISTANCE

Families may apply for a Financial Grant (Traditional Assistance), Work Study, or both. In order to be eligible for any of the programs, **a Tuition Assistance Application must be submitted and on file before April 30, 2012.** Additionally, any family applying for Tuition Assistance is required to submit a copy of their 2011 Federal tax form with W-2's. A letter explaining your circumstances is strongly recommended.

**If funds are available**, we will have an additional financial aid review in September for families missing the first deadline. Applications for this review must be submitted by **August 31, 2012**. A third review for second semester assistance will be held in December. Applications are due by **November 30, 2012**. Your account must be current to be considered for assistance.

**FINANCIAL GRANT** (Traditional financial assistance): Traditional financial assistance is based upon financial need. To be eligible for a Financial Grant, the Tuition Assistance Application, Sections 1 through 5, **with a copy of the 2011 Federal Tax return and W-2's**, must be signed and submitted by April 30, 2012 (see above). Not all applicants are awarded aid. Aid is awarded based upon funding available and criteria listed on the application. Each family is expected to contribute toward its student's education and under no circumstances is 100% aid available. This applies only to Financial Grant applications.

**WORK STUDY:** Available to those families who have need for additional aid. To be eligible for work study, the Financial Aid Application, Sections 1 through 6, **with a copy of the 2011 Federal Tax return and W-2's**, must be signed and submitted by **April 30, 2012**. Primary consideration is given to those families who are applying for a financial grant. After being approved by the Financial Assistance Committee, the Maintenance Department will interview applicants and give final approval. A limited number of positions are available. Work will be done in the summer prior to fall semester with payment made directly to the student with the intent that earnings will be used toward tuition, fees, and expenses for attendance at Bishop Kelly HS.
